The Funds will reopen for applications and redemptions by Authorised Participants on 03 April 2023. This close period arrangement is not applicable for Betashares Active Australian Hybrids Fund (managed fund).

To be eligible, you will need to have purchased your units prior to the Ex Distribution Date, for the transaction to have been settled and for your unitholding to have been entered on the register as of the Record Date.
