

## Notice under ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547

This notice is given by WAM Leaders Limited (ACN 611 053 751) (ASX: WLE) (**WAM Leaders**) under ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547 (**ASIC Instrument 2019/547**).

WAM Leaders refers to its announcement on 14 April 2023 whereby eligible shareholders will have the opportunity to purchase a parcel of fully paid ordinary shares in the capital of WAM Leaders up to the value of \$30,000 (**SPP Shares**) under a Share Purchase Plan (**SPP**).

The SPP will open (and the SPP offer will be made) on 17 April 2023.

WAM Leaders gives the ASX (as the relevant market operator) notice that:

1. WAM Leaders will make offers to issue the SPP Shares under the SPP without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Corporations Act**);
2. this notice is given in accordance with ASIC Instrument 2019/547;
3. as at the date of this notice, WAM Leaders has complied with:
  - (a) the provisions of Chapter 2M of the Corporations Act as they apply to it; and
  - (b) section 674 of the Corporations Act; and
4. as at the date of this notice, there is no excluded information (as defined in subsections 708A(7) and 708A(8) of the Corporations Act, as if this notice was a notice under paragraph 708A(5)(e) of the Corporations Act.
