

SciDev secures \$3.15m PFAS contract in Victoria

Highlights

- SciDev secures contract with Cleanaway Waste Management Limited for the civil design and construction of a water treatment plant to treat per- and poly-fluoroalkyl (PFAS)-impacted wastewater in Victoria.
- The contract, valued at A\$3.15m, will be delivered over six months with revenue from the project expected to commence Q4 FY23.
- SciDev will commence preliminary works immediately, with the plant to be commissioned in November 2023.

SciDev Ltd (ASX: SDV) ('**SciDev**' or 'the Company') is pleased to announce that it has secured a second contract with Cleanaway Waste Management Limited to treat for the per- and polyfluoroalkyl (PFAS) contaminated wastewater. The scope of works will see the civil design and construction of a water treatment plant as well as the integration of the water treatment plant into the liquid waste facility's existing infrastructure.


