# Q3 2023 (March 31, 2023) Activity Report and Appendix 4C

Keypath Education International, Inc. (Keypath or the Company) (ASX: KED) today released its Quarterly Activity Report and Appendix 4C – Quarterly Cash Flow Report for the quarter ended March 31, 2023 (Q3 FY23). The Appendix 4C is prepared in US dollars (the Company's functional and presentation currency) under US GAAP and is unaudited. Similarly, any financial measures presented in the Quarterly Activity Report are unaudited.

## Highlights of Q3 FY23 and Q3 YTD FY23

#### Revenue growth aligned with FY23 full-year guidance:

- Q3 FY23 revenue of US\$33.0 million, 7.0% higher than Q3 FY22 (10.4% higher on a constant currency basis)
- Q3 YTD FY23 revenue of US\$91.7 million, 4.5% higher than Q3 YTD FY22 (8.9% higher on a constant currency basis)
- Q3 FY23 revenue within our Healthcare segment of US\$18.4 million was 21.9% higher than Q3 FY22, while Q3 YTD FY23 revenue within our Healthcare segment of US\$49.7 million was 22.1% higher than Q3 YTD FY22

#### Significant partner and program additions:

- Seven new programs added in Q3 FY23, of which six were in the Healthcare segment in both the US and Australia
- Melbourne Business School ("MBS") and Southeast Asia continue to perform in line with internal expectations with strong pipelines underpinning future growth

### Contribution margin and adjusted EBITDA reflect investment in large vintages:

- There continues to be a large number of programs we have signed recently that are in their deepest investment phase
- Year-over-year comparisons impacted primarily by a tough comparison in Q3 YTD FY22 due to the COVID bump in FY22, with timing of launches, and expected continued pressure in more mature vintages, also contributing
- Continue to target adjusted EBITDA profitability from H2 FY24

### Strong cash position:

- o US\$36.8 million (no debt) as of March 31, 2023
- Confident organic growth fully funded to cash flow breakeven

Keypath's Founder and CEO, Steve Fireng, said "We continue to transition our investments from older vintages to newer vintages and programs where we see the strongest demand and, as expected, contribution margin and adjusted EBITDA have been impacted. We are pleased with the progress and outcomes within our Healthcare and Social Services programs as we continue

to build out a global Healthcare platform. These investments, along with the continued expansion in APAC including with such high-profile partners as MBS, will provide strong and long-term sustainable growth for Keypath.

We have already signed 40 programs from our future vintages (32 of which are from the FY24 vintage). Of the 40 programs, 35 are in Healthcare. Keypath is well-positioned globally to expand its technology and services to continue to help universities provide quality access to education in a digital environment including by continuing to grow our programs across partners and regions."

#### Revenue growth continues

Keypath has continued to deliver revenue growth in line with our FY23 guidance with Q3 FY23 revenue growing 7.0% to US\$33.0 million (10.4% growth on a constant currency basis when adjusted for unfavorable foreign exchange impacts of US\$1.0 million<sup>5</sup>) and Q3 YTD FY23 revenue growing 4.5% to US\$91.7 million (8.9% growth on a constant currency basis). The revenue comparability has been impacted in Australia by the COVID-related increase in enrollments due

1 Contribution margin is revenue less direct costs, which consists of salaries and wages, direct marketing and general & administrative expenses attributable to direct departments. Contribution margin is not a US GAAP based measure.

<sup>2</sup> Adjusted EBITDA is earnings before interest, tax, depreciation, amortization and excluding stock-based compensation. Adjusted EBITDA is not a US GAAP based measure. Note that reported EBITDA for Q3 YTD FY23 was US(\$9.0) million as compared to US(\$13.9) million in Q3 YTD FY22. Q3 YTD FY23 adjustments to reported EBITDA include US\$1.3 million of one-time stock based compensation, US\$1.8 million of ongoing stock based compensation, offset by a \$2.0 million favorable adjustment from the final settlement of the long-term incentive plan cash awards. Q3 YTD FY22 adjustments to reported EBITDA include US\$7.1 million of one-time stock based compensation and long term incentive plan cash awards and US\$1.5 million of ongoing stock based compensation.

<sup>5</sup> The comparisons at constant currency rates (foreign exchange) reflect comparative local currency foreign exchange rates at the prior period's average foreign exchange rates. This measure provides information on the change in revenue assuming that foreign currency exchange rates have not changed between the prior period and the current period. Management believes the use of this measure aids in the understanding of changes in revenue without the impact of foreign currency.

to lockdowns in Q3 YTD FY22 and by the expected softening of enrollments in some programs from mature vintages, weighted to the business vertical, in Q3 FY23.

As of March 31, 2023, our current program count is 204, which represents an increase of 36 programs from March 31, 2022. The seven programs added in the quarter came from the US and Australia, with six coming from the Healthcare and Social Services verticals.

#### Contribution margin and EBITDA performance reflect investment in large vintages

Contribution margin for Q3 FY23 increased by 29.3% to US\$7.5 million and for Q3 YTD FY23 decreased by 6.7% to US\$16.8 million which reflects the large number of programs we have signed recently that are in their deepest investment phase and the FY21-FY23 vintages<sup>6</sup> being very large vintages, in terms of size and investment and expected steady-state revenue.

Adjusted EBITDA of US\$(1.2) million for Q3 FY23 (US\$(7.9) million for Q3 YTD FY23) reflects investments in the new vintages noted above as well as unfavorable foreign currency and increased travel in FY23 exiting COVID lockdowns

The contribution margin and adjusted EBITDA performance also reflects the COVID boost seen in Q3 YTD FY22 creating a challenging comparison figure, and the softening enrollments in mature vintages flowing through to revenue and therefore contribution margin and adjusted EBITDA.

#### Cash Flows and Position

As of March 31, 2023, the Company had total cash on hand of US\$36.8 million reflecting US\$14.7 million of net cash outflow in Q3 FY23 and US\$22.3 million of net cash outflow in Q3 YTD FY23. The Company remains debt-free and confident we are fully funded to cash flow breakeven for the Company's growth objectives.

Net cash used by operations in the quarter was US\$13.2 million and in Q3 YTD FY23 was US\$16.1 million, primarily driven by the seasonality of our cash flows, investments into our large vintages and continuing investments into Asia.

Net cash used in investing activities in the quarter was US\$1.4 million and in Q3 YTD FY23 was US\$4.0 million, primarily representing the capitalized value of employee and contractor costs directly involved in the development of programs and eligible for capitalization under US GAAP.

Net cash used in financing activities Q3 YTD FY23 was US\$2.1 million, representing the amount of cash outflow to satisfy employees' income tax withholding obligations as part of a net-share settlement of stock-based awards and employee stock repurchases.

### **Current Trading and Outlook**

Keypath is driving positive business momentum through FY23 and into FY24 with our growth in partners and programs proving the value of our OPM offering. Our continued expansion in Healthcare and Asia Pacific is providing the foundation for our future growth.

<sup>6</sup> Vintage year or vintage cohort refers to the fiscal year in which the first student intake occurred for any given program. For example, if a program commences on July 1, 2022, it will be classified as an FY23 vintage. Fiscal year is from July 1 to June 30.

We are pleased with the progress we are making in the FY23 transition year of positioning the company for long-term growth through proactively and analytically transitioning our focus and investment into newer vintages comprising programs with improved growth, unit economics and returns profiles.

We are reconfirming our guidance for FY23 of:

- Revenue: US\$125 million US\$130 million on a constant currency basis<sup>7</sup>
- Adjusted EBITDA: US\$(7) million US\$(9) million on a constant currency basis

As of March 31, 2023, we had US\$36.8 million cash (no debt) on our balance sheet; we continue to remain confident we are well funded to cash flow positivity on our organic growth plans and continue to target adjusted EBITDA profitability from H2 FY24.

Keypath is well positioned with growing acceptance among universities and a clear trajectory of accelerating global growth in online learning.
