<p>Answer: The Company has reduced its expenditure levels in recent months pending a share placement which is now completed and it now expects to gradually increase its expenditure. The Company successfully raises money on a regular basis to fund its operations. The Company received \$590,000 (after costs) in April 2023 from a share placement with a further \$2,800,000 (before costs) expected to be received in early June 2023 from a further share placement. In addition, the Company is in the process of disposing of the Granville tenements with a first instalment of \$250,000 expected to be received in May 2023 should the sale complete.</p>
