	<p>The Empire Group has two credit facilities with Macquarie Bank Limited:</p> <ul style="list-style-type: none"> US\$7.5 million debt facility (US\$5.16 million loan availability and drawings) which matures in September 2024. The facility is supported by its gas production assets in the Appalachia region of the USA and carries an interest rate of US LIBOR+650bps. Empire made a US\$137,500 debt repayment during the Quarter reducing the outstanding balance from US\$5,300,010 to US\$5,162,510; and A\$15 million credit facility which is secured by the Company's Northern Territory assets and matures in December 2025. The credit facility is comprised of two tranches: (i) A\$10 million Revolving Credit Facility which carries an interest rate of BBSW+550bps and commitment fee of 40% of the margin on undrawn amounts; and (ii) A\$5 million Performance Bond Facility which carries an interest rate of BBSW+1000bps, commitment fee of 40% of the margin on undrawn amounts
