The Company's 2018 Equity Incentive Plan was lodged with the ASX on 22 October 2018. The options have an exercise price of AUD\$3.56 per CDI, which is above the current CDI price. The term of the options may not extend more than ten years after the date of grant.

On 16 February 2023, the Compensation and Nominating Committee of the Board of Directors vested 181,687 options that had conditionally vested to the Current Holders on 22 February 2022. On 6 April 2023, the Company incorrectly disclosed that these 181,687 options had been exercised by the Current Holders and converted to CDIs. As a consequence, the former ASX Security Code CRNAA ('former class') was removed from the ASX records. However 181,687 options of this former class remain on issue on and from 28 December 2018.
