ClearBridge RARE Infrastructure mFunds – Changes to registry provider

We would like to advise that Franklin Templeton Australia Limited (ABN 76 004 835 849, AFSL No. 240827) (FTAL) as the Responsible Entity for the funds included in this announcement is in the process of transitioning these funds from their current unit registry provider, IRESS Managed Funds Administration, to Link Market Services Limited.

This change will bring the ClearBridge RARE Infrastructure fund range together with other funds issued by FTAL under one registry provider, improving the efficiency and effectiveness of our organisation and the services provided to investors. Importantly, it will not impact how unitholders' investments are managed or the services they receive. This transition includes the mFund Product Issuer Settlement Participant responsibilities and affects the funds listed in the table below.

The effective date of this change is planned for 22 May 2023.
