AMENDMENT TO QUARTERLY CASH FLOW REPORT

Duxton Water Limited (**Company**) advises that immaterial errors have been identified in the Quarterly Cash Flow Report – Appendix 4C lodged on the 28 April 2023.

- Item 4.1 (Cash and cash equivalents at beginning of period \$A'000) is 1,246 (previously reported as 1,248).
- Item 8.4 (total available funding \$A'000) has been incorrectly calculated and is 3,297 (previously reported 5,799). As a result, Item 8.5 (Estimated quarters of fundings available \$A'000) has been updated to 0.7 (previously reported as 1.2).
- Payments to related parties on page 3 has been updated to reflect item 6.1.

An updated Quarterly Activities Report and Appendix 4C is enclosed.

The primary investment objective of Duxton Water ("the Company") is to build a portfolio of permanent water entitlements and utilise this portfolio to provide flexible water supply solutions to our Australian farming partners. The Company generates a return by offering irrigators a range of supply solutions including long-term entitlement leases, forward allocation contracts, and spot allocation supply.



Operational Update

Our focus over the last quarter has been to strengthen and diversify the lease portfolio ahead of the upcoming year. We are pleased to report that during the quarter, we have successfully negotiated a number of new lease arrangements with both existing and new leasing counterparties. We look forward to reporting on our leasing revenue and Weighted Average Lease Expiry ("WALE") for the upcoming water year in due course.

At 31 March 2023, 58% of the Company's permanent water portfolio is leased to Australian farming businesses, which is 4% higher compared to the December 2022 quarter.

Last year, we made the decision to sell the majority of our unleased water allocations to support summer irrigation. While this resulted in an overall benefit to the Company, it meant that Receipts from Customers were below the historical average for the March 2023 quarter. This was compounded by the effect of low allocation pricing that has been seen over the last 2-3 years. In addition to this, Income Taxes Paid for the March 2023 quarter were also higher than average due to the timing of tax payments from the previous financial year.

Australia's weather outlook remains drier than average for the upcoming months, which has seen an increase in demand for leases, forwards, and carry-over products for next season. We continue to speak with our customers about the importance of having a strong water strategy in place ahead of the anticipated changing climatic conditions.

The Bureau of Meteorology issued an El Niño watch in early 2023, meaning there is approximately a 50% chance of El Niño forming in 2023. Global climate models are also forecasting a positive Indian Ocean Dipole ("IOD") event by mid-2023. A positive IOD event typically reduces winter and spring rainfall over most of Australia and can exacerbate dry conditions caused by El Niño.

Entitlement Market

At 31 March 2023, Duxton Water holds 83.8GL of permanent water entitlements across 18 asset types and classes. The Company has increased its portfolio by 0.2GL since the end of the last quarter, and continues to monitor the market for well priced opportunities.

Trading in the entitlement market continues to be quieter than usual for this time of year. Across the southern Murray Darling Basin ("sMDB"), entitlement values decreased by 1.6% during the quarter, with general security entitlements being the greatest contributor to this.

Allocation Market

Lower allocation prices continued to be seen throughout the March quarter, consistent with prices observed for most of the current water year.

Allocation water traded between \$8-\$30/ML in the Lower Murray, \$10-\$30/ML in the Goulburn, \$7-\$15/ML in the Murrumbidgee, and \$5-\$20/ML in the Upper Murray.

Lower allocation prices continue to be a reflection of the prolonged wet conditions seen over the last 2-3 years. Further to that, there is typically little demand for allocation water at this time of year, with irrigators primarily buying for carry-over into the new water year.

Leases

At 31 March 2023, Duxton Water had 58% of its permanent water portfolio (by value) leased to Australian farming businesses, which accounts for 74% of the Company's high security portfolio (by value).

The Company's WALE at 31 March 2023 is 1.3 years or 4.2 years, including renewal options.

The lease market has continued to see an increased level of activity over the last three months, when compared to the previous quarter. This increased demand for leases has been driven by the drier outlook, and irrigators looking for water supply ahead of the upcoming water year.

During the quarter, the Company finalised several new lease agreements, which include renewals of existing leases, and new leases. This will be reflected in the 2023-2024 annualised leasing revenue, leased percentage, and WALE.

The Portfolio Management Team continues to negotiate new leases and forward contracts for the upcoming water year, with both new and existing customers.

Investment Update

At 31 March 2023, Duxton Water's post-tax NAV was \$1.86 per share, which was a decrease of 4 cents per share during the quarter. The decrease is NAV is primarily due to a softening of entitlement values seen across the sMDB, with general security entitlements being the greatest contributor to this.

The Company's NAV, excluding tax provisions for unrealised capital gain, decreased by 9 cents per share during the March quarter, to \$2.13 per share.

Duxton Water's share price closed at \$1.79 at the end of March 2023, up from \$1.62 at 31 December 2022.

Share Buyback

At 31 March 2023, Duxton Water has bought back a total of 3.2 million shares (equivalent to 2.8% of the Company), at an average price of \$1.63 per share since November 2021.

Dividends

On 28 April 2023, Duxton Water pays its 12th consecutive and increasing dividend to shareholders of 3.4 cents per share (fully franked).

This will take total dividends paid to 34.2 cents per share, since the Company's maiden dividend in November 2017. For shareholders invested in D20 since IPO (September 2016), this represents a 45% gross cash return on their investment.

Duxton Water is once again pleased to offer shareholders the ability to participate in the Company's Dividend Reinvestment Plan.

In addition to this dividend announcement, the Board would like to reaffirm the Company's dividend guidance out to the end of 2024:

Debt Update

At 31 March 2023, Duxton Water has \$130 million of debt facilities, with \$128 million drawn at the end of the quarter.

In March, the Company finalised its annual facility renewal with NAB, extending Facility A for 2 years and Facility B for 3 years. Updated debt facility terms are outlined in the Appendix 4C attached to this report.

The Company's Net Debt to Water Assets (LVR) at the end of the quarter was 33%. The current LVR remains within the Company's LVR bank covenant limit of 40%.

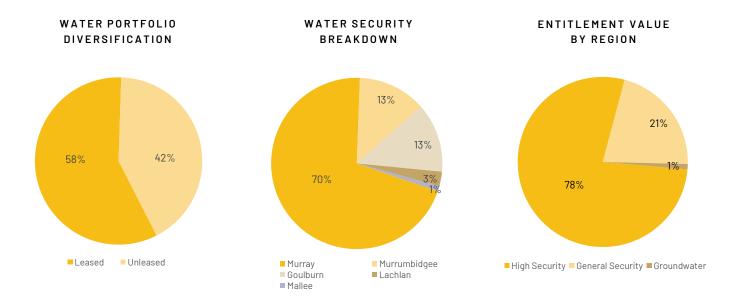

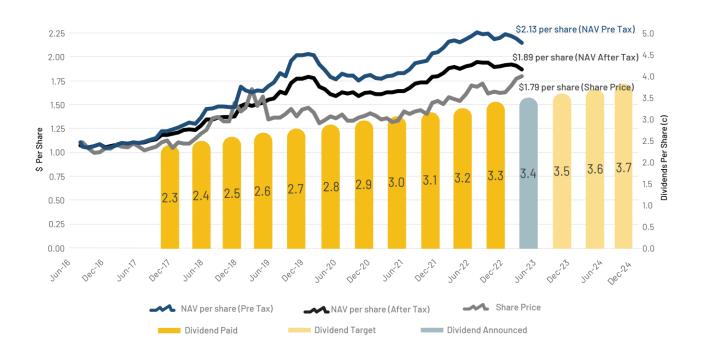
VALUATION METHODOLOGY

 - 1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No.

The Company does not expect to have the same level of operating cash flows as seen in the current quarter. Receipts from Customers are lower than previous March quarters, given the Company decided to sell the majority of its unleased water allocations in 2022. Further to this, Income Taxes Paid were also higher, due to the timing of tax payments for the previous financial year, and the Company also paid a performance fee, for the first time since 2019.

Finally, due to the cyclical nature of Australia's water markets, the Company typically has stronger net operating cashflows in the second half of the financial year due to new season water allocations, and an increased demand for water supply products as irrigators prepare for the new water year.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

The Company has an ability to generate cashflows to fund operations should it need. Cash is generated through the provision of water supply products to its customers:

- Leasing revenue
- Sale of water allocations (inc. forward contracts)
- Carry-over contracts
- Sale of permanent water entitlements

The Board is comfortable of the Company's ability to generate sufficient cashflows to fund its operations through its existing debt facilities and through the provision of the water supply products listed above.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes.

The nature of the Company's revenue streams provides the Board with a high degree of visibility to its cash flows through allocation sales, long-term leasing arrangements, and forward sale contracts. This gives the Board confidence that the Company can continue its operations and meet its business objectives as and when they fall due.
