Re: WBC- CitiFirst Self-Funding Instalment Dividend Announcement

Citigroup Global Markets Australia Pty Limited as Issuer of the WBC CitiFirst Self-Funding Instalments (ASX code WBCSOA, WBCSOB, WBCSOC, WBCSOD, WBCSOE, WBCSOF, WBCSOG, WBCSOH, WBCSOI & WBCSOQ), declared the record date for entitlements to AUD 0.70, fully franked dividend for the WBC CitiFirst Self-Funding Instalment is 12 May 2023, coinciding with the record date for WBC ordinary shares.
