

## **Cleansing Notice**

Thursday, 25 May 2023 - Identitii Limited ('Identitii', 'the Company') (ASX:ID8) advises that it has issued 394,737 fully paid ordinary shares at \$0.095 as final payment for investor relations services rendered to the Company over a 12 month term which concluded in March this year and gives notice under section 708A(5)(e) of the Corporations Act 2001 (*Cth*) (Corporations Act).

The Corporations Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By giving this Notice the shares noted above will fall within the exemption in section 708A(5) of the Corporations Act.
