Important notice: Your CVCG listed Convertible Notes will expire on 22 June 2023

1. Expiry of CVCG

You are registered as the holder of CVC Limited (CVC) unsecured convertible notes which trade on the Australian Securities Exchange (ASX) under the ticker code CVCG (CVCG Notes).

Your CVCG Notes expire at 5:00pm on 22 June 2023, however, the last day that you can trade your CVCG Notes is at close of trading on the ASX on 9 June 2023. All dates and times reflect AEST, or Sydney time.
