Terragen Holdings Limited (ASX: TGH) – Request for Trading Halt

Pursuant to ASX Listing Rule 17.1, Terragen Holdings Limited (ASX:TGH) (**Company**) requests that a trading halt be granted by the ASX in respect of the Company's securities with effect from the commencement of trading on 6 June, 2023.

In accordance with ASX Listing Rule 17.1, the Company:

1. advises that the trading halt is requested to allow the Company to finalise the terms of a proposed equity capital raising (**Capital Raising**) while ensuring that the market does not trade on an uninformed basis;
2. requests that the trading halt remain in place until the earlier of the following:
 - a. the Company has released an announcement of the Capital Raising referred to above; and
 - b. before market opens on 8 June, 2023; and
3. advises that it is not aware of any reason why the trading halt should not be granted, nor of any other information necessary to inform the market about the trading halt.
