## IMPORTANT INFORMATION VANECK MORNINGSTAR INTERNATIONAL WIDE MOAT ETF (ASX: GOAT) CHANGE TO REFERENCE INDEX

VanEck Morningstar International Wide Moat ETF aims to provide investment returns, before fees and other costs that track the performance of the Morningstar Developed Markets ex-Australia Wide Moat Focus Index (**Reference Index**) published by Morningstar Australasia Pty Ltd (**Morningstar**).

Effective market open on 19 June 2023, Morningstar is changing the Reference Index to Morningstar Developed Markets ex-Australia Wide Moat Focus Select Index and removing the momentum screen that is a feature of the Reference Index.

VanEck considers the change is not adverse and is in investors' best interests.

As a result, effective market open on 19 June 2023, any reference to the Reference Index in the Product Disclosure Statement dated 26 September 2022 is replaced with Morningstar Developed Markets ex-Australia Wide Moat Focus Select Index and any references to momentum screen in respect to the Reference Index is deleted.
