On 27 March 2023, PMV announced a fully franked ordinary dividend of AUD 0.54 ("**Ordinary Dividend**") and a fully franked special dividend of AUD 0.16 ("**Special Dividend**") with an ex-dividend date of 20 June 2023 ("**Ex Dividend Date**").

The announcement of the Special Dividend affects certain CitiFirst warrants issued by Citigroup Global Markets Australia Pty Limited ("**CGMA**") (AFSL 240992, ABN 64 003 114 832) over PMV ordinary shares. Pursuant to Section 1.17 of the relevant PDS and with the consent of the ASX where needed, CGMA has adjusted PMV MINIs. The specific ASX Codes affected and the impact of the adjustment is detailed in the table below.

The Strike Price adjustment reflects a reduction on account of both the Ordinary Dividend and the Special Dividend, and the standard change on account of the daily funding amount.

The Stop Loss Trigger Level has also been adjusted taking these changes into account.
