## AngloGold Ashanti Limited (ASX: AGG) – Suspension from Quotation

### Description

The securities of AngloGold Ashanti Limited ('AGG') will be suspended from quotation at the close of trading today under Listing Rule 17.2, at the request of AGG, prior to the voluntary removal of AGG from the official list pursuant to Listing Rule 17.11 at the close of trading on Tuesday, 27 June 2023.

**AngloGold Ashanti Limited (ASX code: AGG) – Request for suspension of securities under Listing Rule 17.2 and termination of quotation and removal from the Official List under Listing Rules 17.10 and 17.11**

AngloGold Ashanti Limited (*AngloGold Ashanti* or the *Company*) refers to its announcement dated 12 May 2023 that the Australian Securities Exchange (**ASX**) agreed to AngloGold Ashanti's request for AngloGold Ashanti to be removed from the official list of ASX pursuant to ASX Listing Rule 17.11 (**Announcement**).

**Request for suspension**

AngloGold Ashanti requests the suspension from official quotation of AngloGold Ashanti's CHESSE Depository Interests (**CDIs**), effective from the close of trading on Friday, 23 June 2023 (**Suspension**) in accordance with the delisting timetable contained in the Announcement.

AngloGold Ashanti provides the following information in accordance with Listing Rule 17.2:

1. AngloGold Ashanti requests the Suspension to enable the settlement of any CDI trades before AngloGold Ashanti is officially delisted from the ASX.
2. AngloGold Ashanti requests the Suspension for a period of two business days (from close of trading on Friday, 23 June 2023 until close of trading on Tuesday, 27 June 2023), at which point AngloGold Ashanti expects to be removed from the official list of the ASX.
3. AngloGold Ashanti made a formal request to the ASX for removal from the official list on 12 May 2023 specifying close of trading on Tuesday, 27 June 2023 as the date for delisting to take effect.
4. AngloGold Ashanti is not aware of any reason why the CDIs should not be suspended.
5. AngloGold Ashanti is not aware of any other information necessary to inform the market about the Suspension.

**Request for termination of quotation and removal from the official list**

Under Listing Rules 17.10 and 17.11, AngloGold Ashanti requests the termination of the official quotation of CDIs on the ASX and that AngloGold Ashanti be removed from the official list of the ASX with immediate effect upon close of trading on Tuesday, 27 June 2023 (**Removal**).

AngloGold Ashanti's request for Removal is in accordance with the delisting timetable contained in the Announcement.

AngloGold Ashanti is not aware of any reason why AngloGold Ashanti should not be removed from the official list of the ASX and is not aware of any other information necessary to inform the market about the Removal.
