- 4) Select 'Add Bank Account'

This information can be found on your holding statement. Your reference number will start with an "I" if you are issuer sponsored or "X" if you are sponsored by a broker (CHESS).

It is not our intention to hedge the foreign currency exposure of the Fund arising from investments in overseas markets.
