## Pre-quotation disclosure

5 July 2023: Embark Education Group Limited ("Embark" or "Company") refers to the ASX announcement lodged on 21 June 2023 detailing that final court orders from the New Zealand High Court were received on 20 June 2023 to implement the scheme of arrangement under part 15 of the New Zealand *Companies Act 1993* (Scheme of Arrangement) approved by shareholders at an annual meeting held on 6 June 2023 to redomicile Embark by listing on the Australian Securities Exchange (ASX) (ASX Listing) and delisting on the NZX.

#### Purpose of this document

The information below is provided to complete the final pre-quotation requirements of the ASX in connection with the admission of Embark Early Education Limited (Embark Parent) to the official list of the ASX and official quotation of Embark Parent's fully paid ordinary shares (Shares) on the ASX.

#### Matters in connection with the Scheme of Arrangement

Embark confirms that all conditions precedent with respect to Scheme have been satisfied (and not waived), and in particular:

- (a) Embark shareholders approved the Scheme on 6 June 2023; and
- (b) A court of competent jurisdiction made orders approving the Scheme on 20 June 2023.

On the implementation of the Scheme, being, today 5 July 2023:

- (a) all Embark's shares were transferred to Embark Parent and Embark Parent became the sole holder of the Embark shares; and
- (b) each Eligible Shareholder of Embark was issued one Share in Embark Parent for each Embark share they held on the record date for the Scheme (being 7.00pm (New Zealand time) on 28 June 2023).

Embark also confirms that as at the date of this announcement, the scheme plan pursuant to part 15 of the New Zealand *Companies Act 1993* set out in Schedule 1 of the Scheme booklet dated 19 May 2023 ('Scheme Plan') remains in force and effect.

#### Issue and dispatch dates

The intended date for dispatch of the holding statements for the Shares issued under the Scheme (in respect of both CHESS and issuer-sponsored holdings) is 6 July 2023.
