SciDev secure A\$7.0m mineral sands contract for the supply of Maxiflox® chemistry

Highlights

- ▶ SciDev has secured a two-year contract (with the option for a two-year extension) at the Thunderbird Minerals Sands Project
- ▶ The contract is expected to generate approximately A\$7.0 m in sales over the initial two-year period
- ▶ SciDev has secured over A\$44 million in Total Contract Value in the past 6-months in the resources sector.

SciDev Ltd (ASX: SDV) ('**SciDev**' or '**the Company**') is pleased to announce that it has secured a two-year contract (with option to extend for an additional two-years) at the Thunderbird Minerals Sands operation ('Thunderbird') for the supply of MaxiFlox® chemistry, OptiFlox® equipment and technical services. Thunderbird, located on the Dampier Peninsula in Western Australia is a large, high grade minerals sands project being developed by Kimberley Mineral Sands Pty Ltd, a 50:50 joint venture between Sheffield Resource Limited (ASX:SFX) and Yansteel. Revenue under the contract is anticipated to commence in 1H FY24 as the Thunderbird project ramps up to production.

The contract with Thunderbird further extends SciDev's presence within the mineral sands extraction industry where our chemistries allow clients to reuse water, improve operational efficiencies and reduce their environmental footprint.

SciDev CEO Seán Halpin said, "The contract with Thunderbird was secured following a competitive tender process which highlighted the superior operational efficiency and productivity benefits of our MaxiFlox® chemistry solutions. Our technical expertise and bespoke chemical solutions are continuing to deliver increased market share across the resource sector which is reflected in over \$44m of new contract value secured in the past six months. With a growing footprint in the global resource sector, established presence within the energy services sector and expanding PFAS opportunities globally, SciDev is well positioned for continued growth and to deliver lasting returns for our shareholders."

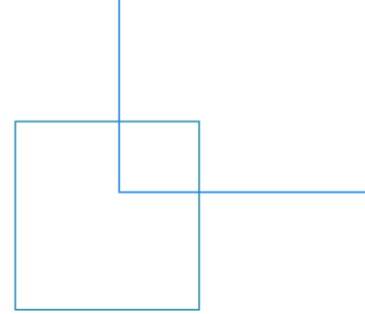
