**Nightingale Intelligent Systems, Inc. (ASX: NGL)
Correction to Appendix 3G lodged 5 July 2023**

Nightingale Intelligent Systems, Inc (the **Company**) has become aware of a minor error in the Appendix 3G lodged with ASX on 5 July 2023 (the **First Notice**).

The First Notice disclosed the issue by the Company of 407,709 unlisted options over shares of common stock with a ten-year term expiring 26 June 2033 and an exercise price of US\$0.04 (ASX: NGLAP). The unlisted options were issued to executives and employees in lieu of a portion of their cash salary under a plan which commenced in March 2023. Details of the plan were disclosed in the Company's Q1 2023 and Q2 2023 Quarterly Reports. The options in the Notice related to the June payroll.

Attached to this letter is an Appendix 3G which amends the First Notice by confirming that the correct number of unlisted options issued by the Company in respect of the June payroll was 383,515. All other details of the unlisted options disclosed in the First Notice are correct.
