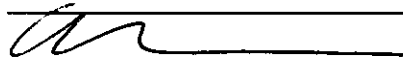

### Nature of Change

Liquipure has ceased to be an associate of any Other Requisitionists, and has no relevant agreement with any of them, as the resolutions set out in the Notices were passed at the general meeting of IOUPay held on 3 May 2023.

At the time of the previous notice, Liquipure had a relevant interest in 98,989,095 ordinary shares of IOUPay.
