## **ASX Announcement (ALO)**

# Alloggio's Shareholders vote in favour of Scheme of Arrangement

Alloggio Group Limited (**ASX:ALO** or **Alloggio**) announces that Alloggio's Shareholders have today voted in favour of the proposed acquisition of 100% of ALO by ALO Bidco Pty Ltd, Next Capital Pty Limited's nominee, by way of a scheme of arrangement (**Scheme**).

### **Results of the Scheme Meetings**

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Alloggio advises that the resolutions to approve the Scheme (**Scheme Resolution**), as set out in each of the Notice of Meetings included in the Scheme Booklet dated 7 July 2023, were passed by the requisite majorities of Alloggio's Shareholders at the Scheme Meetings held earlier today pursuant to orders made on 7 July 2023 by the Federal Court of Australia (**Court**).

#### In summary:

- General Scheme Meeting:
  - 97.35% of General ALO Shareholders present and voting (in person or by proxy, attorney or corporate representative) voted in favour of the Scheme Resolution; and
  - 99.92% of the votes cast by General ALO Shareholders present and voting (in person or by proxy, attorney or corporate representative) were in favour of the Scheme Resolution;
- Founding Shareholders Scheme Meeting:
  - 100% of Founder Shareholders present and voting (in person or by proxy, attorney or corporate representative) voted in favour of the Scheme Resolution; and
  - o 100% of the votes cast by Founding Shareholders present and voting (in person or by proxy, attorney or corporate representative) were in favour of the Scheme Resolution.

Details of the valid proxies received and votes cast at the General Scheme Meeting and the Founding Shareholders Scheme Meeting are set out in an attachment to this announcement.

#### **Next steps**

The Scheme remains subject to the approval of the Court at the hearing scheduled for 10:15am (Sydney time) on 28 August 2023, and certain other customary conditions precedent as previously announced and described in the Scheme Booklet.

If the outstanding conditions precedent are satisfied or waived (if applicable) prior to the hearing, and the Court approves the Scheme, Alloggio proposes to lodge an office copy of the orders of the Court with the Australian Securities and Investments Commission (ASIC) on the same day (28 August 2023), at which time the Scheme will become legally effective. It is then expected that:

- Alloggio will apply for its shares to be suspended from trading on the ASX from close of trading on 28 August 2023; and
- the Scheme will then be implemented on 6 September 2023, at which time the Scheme Consideration will be paid to ALO Shareholders.
