## **Baltec IES secures new \$12M contract**

The Environmental Group Limited (ASX: EGL) is pleased to announce a major contract win for Baltec IES for the engineering, design, and supply of two gas turbine silencer & exhaust gas systems to Jurong Engineering Limited in Singapore. Baltec IES will undertake this work over the next 10 months with delivery expected to Singapore in mid-2024. The engineering has required complex acoustic designs to minimise the environmental impact of multiple turbines on the same site. Our unique silencer design has been able to meet the clients strict noise requirements whilst optimising turbine performance.

Gas turbines are widely used to support the renewable-energy sector by supplementing peak load energy requirements. This requires the turbine to be able to deal with the thermal dynamics of heating and cooling into the thousands of cycles. Coupled with mechanical and structural design, our silencer technology has brought together a world class product and the largest silencer ever delivered by Baltec IES.

EGL CEO Jason Dixon said,

*“Over 4 years has been spent developing our silencer technology to reduce the noise impact on our environment. To design acoustic systems in such a complex environment is a testament to the strength of our intellectual property. Our engineering teams have worked to design a unique technical solution and should be very proud; they have been able to achieve a world class solution for the project”.*

Securing the Jurong project brings the value of contracts won by Baltec IES year to date to \$17.6M, setting Baltec IES up for strong performance in the current financial year.
