Update regarding CEO Termination

Sydney, 21 August 2023 - **Wisr Limited (ASX: WZR) (Wisr**, or the **Company)** announced on 16 August 2023 that the Wisr Board had terminated Chief Executive Officer Anthony Nantes' employment.

The Wisr Board confirms that Anthony Nantes' termination was not occasioned by any financial irregularity or regulatory contravention and the Company continues to conduct business as usual. The Wisr Board had formed the view over recent months that Anthony was unable to perform the role of CEO to the level required by the Board and as such the Board took action in terminating his employment agreement.

Wisr is aware that Anthony Nantes is the subject of criminal proceedings brought by NSW Police. As these matters remain before the courts, the Company is not able to comment further.
