



MONTHLY SUMMARY


The portfolio recorded a negative return in August.

The largest detractors over the month were Transurban, Norfolk Southern and Eversource Energy. Australian toll road operator Transurban traded down on rising Australian bond yields as well as slightly weaker-than-expected traffic in one of its key markets. US-based rail company Norfolk Southern fell as US bond yields jumped and as they reduced full-year revenue expectations at their H1 result in late July on a slower-than-expected recovery in volumes post the derailment as well as declining fuel surcharges and storage revenue. US utility Eversource Energy was affected not only by rising US bond yields but also by its partner in its offshore wind projects taking an impairment on those projects.


