Giselle is a Graduate Member of the Australian Institute of Company Directors and a Member of Chartered Accountants Australia and New Zealand. Giselle has a Bachelor of Economics degree from the University of Sydney and a Graduate Diploma in Applied Finance and Investments from the Securities Institute of Australia.

Zita Peach, PSQ's Chairperson, said: "As previously communicated, Board renewal and succession planning has been a priority for Pacific Smiles and Giselle's appointment ensures we have additional expertise in key areas. Giselle's deep experience as a career finance executive is supplemented by her strong commercial acumen and will complement the experience of the current Directors."

Pacific Smiles Non-Executive Director and Chair of the Audit & Risk Management Committee, Simon Rutherford, advised the Board of his intention not to stand for re-election and to retire as an Independent Director at the close of the 2023 AGM.

Zita Peach said: "The Board would like to acknowledge the significant contribution Simon has made to the growth and success of Pacific Smiles. He has been an unwavering advocate of the company and an active contributor to protecting our strong financial position. He has been

a highly dedicated and respected Board member that has been part of the evolution of Pacific Smiles.

The Boards succession planning will see Giselle appointed as Chair of the Audit & Risk Management Committee at close of the AGM.
