BikeExchange Limited ACN 625 305 240 (ASX:BEX) (**Company**) advises that on 22 September 2023 it has issued the following shares as set out in the Appendix 2A dated 22 September 2023:

- 40,119,796 fully paid ordinary shares (Bonus Shares) issued at the price of \$0.009 per share to the employees including the CEO and CFO in lieu of a cash bonus.
