## Re: VHY - CitiFirst Self-Funding Instalment Distribution Announcement - Estimated

Citigroup Global Markets Australia Pty Limited as Issuer of the VHY CitiFirst Self-Funding Instalments (ASX code VHYSOA, VHYSOB, VHYSOC, VHYSOD, VHYSOE, VHYSOF & VHYSOG), declared the record date for entitlements to the estimated AUD 1.301639, unfranked distribution for the VHY CitiFirst Self-Funding Instalment is 3 October 2023, coinciding with the record date for Vanguard Australian Shares High Yield ETF.
