#### **Delisting**

With the delisting of the Company now approved by way of special resolution of the shareholders, the Company expects to be removed from the Official List of the ASX on Monday 30 October 2023 after close of market trading (**Delisting**).

As detailed in Sunland's ASX announcement dated 24 August 2023, shareholders will be able to seek to sell their shares on the ASX prior to the Delisting. However, in accordance with the ASX conditions of the Delisting, Sunland will apply to be suspended from trading with effect on and from 26 October 2023 (2 business days prior to the Delisting).

After the Delisting, shareholders may be able to trade shares off market, however Sunland will not be providing any platform or making any special arrangements for shareholders to buy and sell their shares.

After the Delisting has occurred, Sunland intends to comply with its continuous disclosure obligations by disclosing material information on its website in a timely fashion, in accordance with the good practice guidance in ASIC Regulatory Guide 198.
