Appointment of Interim CEO

Mighty Kingdom Limited ("MKL" or the "Company") advises the following management changes with immediate effect.

Mr Simon Rabbitt, MKL's current Chief Financial and Operations Officer ("CFOO"), will assume the role of Interim Chief Executive Officer ("Interim CEO") as the Company continues to focus its efforts on delivering on current contracts, building its development pipeline and assessing strategic options for future growth. In parallel to this appointment, the Company will be commencing a formal process to identify and appoint a permanent CEO.

Mr Rabbitt, with 11 years of executive experience, has served in key financial and operational roles within the Media, Sports and Entertainment industries. Prior to joining Mighty Kingdom, Mr Rabbitt held positions as Chief Business Officer for Rugby Australia and Chief Operating Officer for FremantleMedia - Australia and Asia.

As the architect of the Company's efforts in restructuring and executing on a sustainable business model, Simon has led the management team's efforts in the positive turnaround of the business over the past nine months. He will continue to fulfill the responsibilities of his current CFOO contract during the period of this Interim appointment with the support of additional oversight at the board level.

The Company's Chair, Ms Michelle Guthrie, commented:

"Simon has made an incredible impact since he joined the Mighty Kingdom team with the Company's focus under his leadership delivering real results. His appointment as Interim CEO will place the Company in the best possible position to evaluate the options available to it going forward as we look to rebuild shareholder value."

Interim CEO Remuneration:

In accordance with ASX Listing Rule 3.16.4, a summary of the key terms of the agreement between the Company and Mr Rabbitt is provided below. Mr Rabbitt currently holds the position of Chief Financial and Operations Officer for MKL with the terms below also reflecting his current contract.

Fixed Remuneration

Under the terms of Mr Rabbitt's Interim CEO contract, he will receive total fixed remuneration of \$300,000 per annum, plus superannuation, for the period he holds office as Interim Chief Executive Officer.

Short Term Incentives

A Short Term Incentive of 50% of Fixed Remuneration is payable based on achievement of agreed KPI's.

Long Term Incentives

Subject to shareholder approval the Company will issue to Mr Rabbitt an additional 4,000,000 unquoted share options, each with the right to be issued one Company share for a strike price of \$0.04 and a two-year expiry term. Each option will upon exercise convert to one fully paid share in the Company. All options will vest upon grant. Until an option vests, it cannot be exercised.

Termination

The obligation to provide the services will end upon either party giving the other party 6 months notice in writing of the termination of this Agreement.
