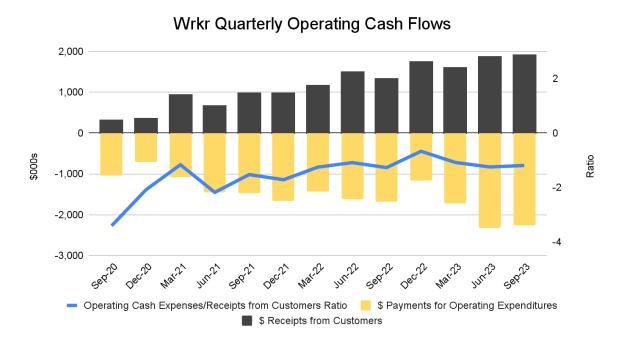

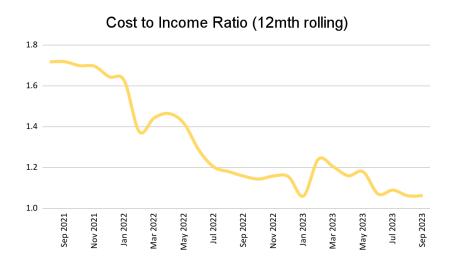
Q1 2024 FINANCIAL HIGHLIGHTS



Q1 FY24 cash receipts from customers +43% on pcp (\$1.89m Q1FY24; \$1.33m Q1FY23)



- Q1 FY24 Revenues +14% from Q4 FY23 (\$2.02m Q1 FY24; \$1.78m Q4 FY23)
 - Increase in our platform as a service annual licence and monthly support and maintenance fees as a result of the development work performed by the team with the Australian Retirement Trust's Beam platform in FY23 to provide additional customer led, innovative features.
 - SMSF Hub continues to perform well with continued increases in revenue month on month. Q1 FY24 revenues +60% on pcp (\$187k Q1 FY24; \$116k Q1 FY23)
- The cost to income ratio continues to trend in a positive direction demonstrating the business' commitment to investment for growth.





Business Strength

The start of the 2024 financial year has seen considerable activity in the business.

- Commencement of contract with Link Group with estimated value of \$3m over 3
 years to uplift employer solutions including clearing house and Superstream
 Gateway infrastructure
 - \$3m estimated value covering licences, integration to Link Group's administration platform, fund onboarding and support services.
 - Additional revenues from usage fees for contributions management and messaging on a transactions basis once Link's administered funds are onboarded and as employers use the service.
 - Full stack of Wrkr Products, including Wrkr PAY and Wrkr READY, will be accessible through direct contract between employers and Wrkr as the Wrkr Platform is implemented to new and current superannuation fund clients.
- Wrkr is positioning itself for the Payday Super changes anticipated to be introduced from 1 July 2026. Wrkr is heavily engaged in consultation groups and forums on the reforms, and sees Payday Super as an incredible opportunity for the growth of the business with average volumes of annual contribution payments are expected to increase by 2-3 times as per Wrkr's initial estimates. Wrkr is focusing on ensuring long-term contracts are structured around transaction fees and licences, and as we anticipate a shift to real-time payments as the Payday Super changes take effect, Wrkr continues to work to ensure it does not strategically rely on float income.
- Our Customer Success Team ramped up the marketing of Wrkr PAY in Q1 with a
 variety of communications going out to our target markets via direct emails, Linkedin
 and our website. These communications highlight the benefits of the Wrkr PAY
 platform:



- Vastly improved user experience from Clicksuper
- o Compliance with a simple intuitive user interface
- Avoid manual data export and reporting errors
- Real-time data verification
- API integrations with HR and Payroll solutions

The key message to the customer market is that Wrkr PAY reduces the risk of non-compliance using a contemporary experience that saves you money. With technology designed to simplify complexity and support for onboarding employees, Single Touch Payroll (STP), Wages, and Superannuation Guarantee (SG) obligations, Wrkr PAY can provide much-needed relief for businesses when managing complicated compliance requirements and time-consuming processes.

 Wrkr continued its investment into its Cyber Security Program with the appointment in August of a Senior Cyber Security Engineer further enhancing our cyber posture.

Q2 FY24 Focus

- Continuing the detailed design and implementation of the clearing house and Superstream Gateway infrastructure and employer portal for Link, while continuing discussions with Link around the profile and timing of the funds to be onboarded.
- Ensuring we are ready to take advantage of the potential opportunity to provide our full suite of Wrkr PAY and Wrkr READY services to employers when the Wrkr technology solution is implemented to employers through Link's Fund customers.
- Exposing the Wrkr platform at an API level with scalable and innovative solutions to enable the quick and easy activation of the platform with potential customers.



Other

The cash expenditure incurred on the activities of the business in the quarter are summarised as follows:

- \$1,352k Staff costs
- \$542k Administration and corporate costs
- \$280k Operating costs
- \$83k Finance Costs
- \$22k Advertising and marketing

As required to be disclosed under ASX Listing Rules, payments to related parties in the current quarter amounted to \$77k. This amount is shown in Appendix 4C under Section 6. Payments to related parties of the entity and their associates relate to directors' fees (\$64k), and interest paid on convertible notes held by an associated entity of related parties (\$13k).

Wrkr provides compliance and payment software solutions to create efficiencies for Superfunds, payroll service providers and both large and small Australian employers.

- Wrkr PLATFORM, a modern cloud-based compliance platform for handling messaging with ATO (SuperStream, STP 2.0, PEPPOL, SBR and State authorities) and orchestrating payment processing for worker pay and super contributions for Fund Administrators
- Wrkr PAY, a superannuation gateway and clearinghouse and payment handling solution for secure processing of employee pay and super contributions for Payrolls and Superfunds.
