These loans are secured against real property in China. Other financing facilities include (figures denominated in A\$000): - Loans provided by related parties to the Group – \$6,576 – provided by Executive Director Mdm Kang Rong on an interest free basis and repayable on demand. - Other short-term loans in China – \$3,718 – These are short-term loans entered into by the Chinese operations, denominated in RMB, including: - o \$1,150 is interest bearing between 4.7% - 5.6%, secured against certain right-of use assets held in China and payable in October 2025 and March 2026; - o \$1,124 is interest bearing at 10%, secured against certain right-of use assets held in China and payable in March 2024; and - o The remainder is non-interest bearing with no fixed repayment date. - Convertible notes \$5,365 – The convertible notes (the Notes) have a term of two years maturing in March 2024 and are convertible into ordinary shares of the Company at \$0.54 per share. The Notes carry a 10% per annum coupon which was paid up front through the issuance of an additional notes at the date of issue. The Notes are secured by a first ranking general security agreement, guarantee and registered mortgage over real property held by Donald Mineral Sands Pty Ltd (a 100% owned subsidiary of the Company).

	Answer: No. Net operating cash outflows experienced during Q1 2024 within the Chinese operations were abnormally high due to the plant being placed in care and maintenance during March 2023. The plant is expected to recommence operations in November 2023 with minimal working capital impost. It is anticipated that the operations will commence receiving cash inflows from production in December 2023 which should offset the fixed costs of the operations.

	Answer: The Company is currently investigating several options to secure further cash to fund its operations and expects to that the Company's primary strategy will be successful. The Company anticipates informing the market at the completion of these negotiations.
