The facility is for up to \$6.5 million, interest rate on drawings is 8%, is repayable on 31 December 2024 and the facility is unsecured. As at 30 September 2023 the facility has been drawn to \$753,000. In addition the Company has a short term loan facility provided by Norfolk Enchants Pty Ltd, an unrelated third party. The facility principal is for up to \$6m, has an interest rate of 20% per annum and is repayable on 31 October 2024. The facility is secured by a fixed and floating charge over the assets of the Company. As at 30 September 2023 the facility had been drawn to \$5,750,000.
