Correction - Results of 2023 Annual General Meeting

Atomo Diagnostics Limited (ASX: AT1) (**Atomo**) refers to the announcement titled 'Results of 2023 Annual General Meeting' released on ASX's Market Announcements Platform at 2.00pm (AEDT) today.

It has been brought to Atomo's attention that Share Registry has incorrectly classified the voting result of Resolution 7 (Additional 10% Placement Capacity) as 'Carried'. The attached summary is provided to correct the error and replace the summary lodged earlier today. All the statistics remain unchanged.

All resolutions were conducted by way of a poll pursuant to section 250JA of the *Corporations Act* (Cth) (the **Act**).

Atomo confirms that all resolutions were passed with the requisite majority, except for Resolutions 2, 6 and 7.

In accordance with ASX Listing Rule 3.13.2(f), Atomo advises that more than 25% of the votes cast on Resolution 2 were against the adoption of the 2023 Remuneration Report and therefore constitutes a "first strike" under section 250U of the Act.
