## CitiFirst Commodity MINIs Amendments to Terms of Issue

Citigroup Global Markets Australia Pty Limited (ABN 64 003 114 832 and AFSL 240992) (**Citi**) issued the product disclosure statements (each a **PDS**) in relation to CitiFirst Commodity MINIs quoted on the ASX specified in Annexure B to this notice (each a **CitiFirst Commodity MINI**).

Citi proposes to amend certain terms of issue of each CitiFirst Commodity MINI under paragraph 10.3.6(e) of Schedule 10 of the ASX Operating Rules (the **Changes**). The changes are described in Annexure A of this notice.

The Changes take effect at 5pm (Sydney time) on 8 November 2023.

Citi hereby provides notice of the Changes to holders of CitiFirst Commodity MINIs.

## Annexure A - Description of amendments

Citi proposes to amend the terms of issue as follows:

- (a) in section 2.4 ('What Happens If An Issuer Call Occurs?') of the PDS, by inserting the blue underlined text as follows:
  - By giving Holders at least one calendar month's notice, Citi may, acting commercially reasonably, terminate a Series of CitiFirst Commodity MINIs (in whole but not in part).
- (b) in section 9 of the PDS, in clause 3.1c)iv of the terms of issue, by deleting the red struck through text and inserting the blue underlined text in substitution as follows:

  the CitiFirst Commodity MINI has not been terminated or suspended from trading for any other reason (as determined by Citi in its absolute discretion acting reasonably).
- (c) in section 10 of the PDS, the definition of 'Settlement Date', by deleting the red struck through text and inserting the blue underlined text in substitution in subclause c) as follows:
  - such other date as determined by Citi, acting reasonably, at its absolute discretion and notified to the Holder.
