Ignite Limited ("Ignite") - Results of the 2023 Annual General Meeting.

The attached information regarding the results of resolutions put to the Annual General Meeting of Ignite Limited held today is provided in accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act.

All resolutions put to shareholders were decided upon by polls.

Resolution 1: Election of Mr Garry Sladden as a Director

Mr Garry Sladden was elected a Director of the Company.

Resolution 2: Adoption of Remuneration Report

Although the ordinary resolution to adopt the Remuneration Report for the year ended 30 June 2023 was passed on a poll by a majority 58.79%, as more than 25% of the votes cast were against the adoption of the Remuneration Report, a "Second Strike" resulted. Consequently, the Spill Resolution, Resolution 5 had to be put to the meeting.

Resolution 3: Election of Mr Daniel Altiok Brown as a Director

The resolution to appoint Mr Daniel Altiok Brown as a Director was not passed.

Resolution 4: Election of Mr Trevor Robertson as a Director

The resolution to appoint Mr Trevor Robertson as a Director was not passed.

Resolution 5: Spill Resolution

The Spill resolution was not passed.
