#### Revasum, Inc. - Request for Trading Halt

Pursuant to Listing Rule 17.1, Revasum, Inc. (ARBN 629 268 533) (Revasum or the Company) requests a trading halt in respect of its CHESS Depositary Interests (ASX: RVS) with immediate effect.
