Answer: The board continually reviews its cash requirements to ensure that sufficient cash is available to fund its operating activities and its capital raising options.

The company is in the process of finalising its research and development tax offset for the 2023 financial year which is expected to generate \$330k in funding. To assist with the cash flow requirements, the Company had negotiated a short-term loan facility of \$160k which is repayable from the expected tax offset refund. The balance of \$170k is expected to be received in November 2023.

8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, in addition to the comment in 8.6.2. The Company is negotiating with several interested parties for the implementation of its technology and based on the current "burn" rate sufficient funds will be available until these negotiations are concluded.
