Qantas is targeting a buy-back of up to \$500 million of its ordinary shares. The buy-back may consist of two tranches, the first being within Qantas' remaining 10/12 Limit under the Corporations Act, and the second tranche exceeding the 10/12 Limit, following shareholder approval at the 2023 AGM.

Qantas may, at its discretion, vary the size of the buy-back subject to certain restrictions, and also retains the discretion to purchase a lesser value of shares, or no shares at all.
