**US Masters Residential Property Fund (Fund)**  
**Net Asset Value as at 8 December 2023**

The weekly estimated unaudited net asset value (**NAV**) before withholding tax as at 8 December 2023 was \$0.69\* per unit.

If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value as at 8 December 2023 would be \$0.62\* per unit.

**Calculation of weekly NAV**

This weekly unaudited NAV estimate has been calculated by reference to the Fund's most recent estimated unaudited fully diluted monthly NAV at 31 October 2023 (being \$0.71 per unit on a pre-tax basis and \$0.64 per unit on a post-tax basis which applied an AUD:USD foreign exchange rate of 0.6337) and adjusting for changes in the AUD:USD foreign exchange rate.

The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 8 December 2023 was 0.6579.

These weekly estimates do not take into account all intra-monthly accruals, which are incorporated in the monthly NAV updates.
