

EP&T successfully becomes an approved supplier to the UK Government Crown Commercial Service

Building energy optimisation company EP&T Global Limited (ASX: EPX) is pleased to announce recent success in becoming an approved supplier to the UK Government Crown Commercial Service, opening a potential large opportunity to supply the UK government and public sector.

EP&T has been successful in becoming an approved supplier to the Crown Commercial Service in the United Kingdom (UK). This designation provides for EP&T to be a pre-approved service provider under two large UK Government procurement frameworks for a 4-year term.

While EP&T is still required to submit proposals to UK Government departments and Public Sector entities, this designation provides a quicker route for those entities to procure services and technology from the Company, to meet its Net Zero 2050 target. The two frameworks are:

- Demand Management & Renewables (HELGA 2) framework This framework has a
 potential spend value of £1Bn, targeted to be procured over a 4-year term. The UK
 Government is indicating it is seeking to procure approx. 33% of this framework from
 Small/Medium Enterprises (SME's), such as EP&T. Services targeted to be procured
 by UK government under this framework, for which EP&T expects to tender, include:
 - Energy Efficiency in Buildings;
 - Energy Performance Certification (GRESB, etc); and
 - Building management systems and automated meter analytics.
- Facilities Management & Workplace Services framework This framework has a potential spend value of £500m, targeted to be procured over a 4-year term. Also under this framework, the UK Government has set a target of procuring approx. 33% of contracts from SMEs. Services targeted under this framework, include the following services of interest to EP&T:
 - Smart FM solutions including Computer Aided Facility Management (CAFM) services;
 - Statutory Obligations/Compliance Services in ESG and sustainability;
 - measurement and management, including net zero strategies; and
 - Maintenance Services, including predictive maintenance analytics.

EP&T CEO, John Balassis said, "being selected to be a Crown Commercial Services approved supplier is a great step for the company, and testament to our ongoing success in the UK market. We are now able to showcase our capability and EDGE building efficiency platform to UK Government departments and Public Sector entities. This was a rigorous process, so it is pleasing to see EP&T being selected. It provides EP&T an opportunity to continue to open new sale verticals in the UK market."
