Oneview Healthcare plc - Year-End Business Update

Melbourne, Australia – 2 January 2024. Oneview Healthcare plc wishes to update the market on a number of key developments.

Hardware deliveries for two US and one European customer which were envisaged to ship in December have slipped into 2024 due to unexpected project delays. This will have the effect of reducing total revenue for 2023 by approximately €2.9m (A\$4.7m) and will mean that the Company will now deliver total revenue of approximately €9.3m (A\$15.1m) for the full year 2023. Hardware revenue by definition is erratic and lower margin and this €2.9m is now expected to be recognised in H1 2024. The Company's strategic initiative to move to a BYOD model will, in time, reduce such quarterly volatility by reducing the need for in-room hardware.

Despite these revenue deferrals, the Company has enjoyed a strong fourth quarter with customer receipts of €4.3m (A\$7.0m) and finished the year with cash on its balance sheet of €11.5m (A\$18.8m), reflecting an operational cash burn for the fourth quarter of €0.12m (A\$0.20m).

The Company has recently signed the new Dunedin Hospital in New Zealand, representing our first customer in that country. The Company remains in promising late-stage negotiations with two other major US health systems, representing over 2,800 beds.

The Company has completed marketing of Phase I of the BYOD product and, as a result, has secured partnership agreements with both NYU Langone Health, the #1 hospital in New York, and the Bon Secours Health System, one of the largest providers of private healthcare in Ireland (with 900 beds across 5 hospitals), to pilot this product in January 2024.

Following the formal launch of the Baxter partnership on 6 November last, the first purchase orders from Baxter are expected in the coming weeks.

This release has been approved by the Board of Oneview Healthcare plc.
