The Appendix 3B dated 11 January 2024 disclosed that ReNu Energy agreed to issue 25m Options to PAC Partners Securities Pty Limited (PAC Partners) for lead managing/underwriting the Entitlement Offer announced 21 November 2023.

ReNu Energy subsequently announced a Share Placement on 11 December 2023, which was also lead managed/underwritten by PAC Partners. The previous Appendix 3B did not include additional Options agreed to be issued



to sub-underwriters of PAC Partners in relation to the Entitlement Offer and Share Placement, which were agreed after entering the initial Underwriting Agreement.

This Appendix 3B discloses that ReNu Energy agreed to issue 25m Options to Cygnet Capital Pty Ltd for acting as sub-underwriter to the Entitlement Offer and Placement.
