Scheme Consideration - Bank Account Details

Lithium Power International Limited (ASX: LPI) ("LPI" or "the Company") advises that Shareholders have approved the proposed Scheme of Arrangement pursuant to which a wholly-owned subsidiary of Corporación Nacional del Cobre de Chile (Codelco), Salar de Maricunga SpA, will acquire 100% of the issued shares in LPI (Scheme).

Pending court and other approvals, the Scheme consideration of A\$0.57 per LPI share will be paid to Shareholders on the implementation date for the Scheme (currently anticipated to be 23 February 2023).

We encourage Shareholders to provide a bank account to expedite the receipt of the Scheme consideration (if the Scheme is implemented).
