Quarterly Activities Report

For the period ended 31 December 2023

Corporate

Investor Centre released its preliminary final report for the year ended 30 June 2023 and Annual Report on 31 August 2023. The Company recorded revenue of approximately \$1.3 million in fiscal 2023 and a net loss of around \$1.4 million, a substantial improvement on the previous year's result (loss of \$3.1 million). The Board is confident the Company's new strategy can deliver enhanced performance in the year ahead.

An Extraordinary General Meeting was held on Friday, 17 November 2023 to approve the new preference share (details in the Notice of Extraordinary General Meeting was released to the ASX on 19 October 2023).

Investor Centre held its Annual General Meeting on the same date and venue, from 12pm (Qld time).

All resolutions in both meetings were passed.

Key Business Activities December Quarter 2023

Capital Raising

Investor Centre Limited (IC) is undertaking a capital raise involving the issue of between 140,000 and 360,000 "A" Class Redeemable Preference Shares at an issue price of \$25.00 to raise between \$3,500,000 and \$9,000,000. The Offer is expected to close on 1 March 2024. The proceeds of the offer will be used to fund the proposed acquisition of Investor Centre Data Pty Ltd (subject to shareholder approval and a number of other conditions precedent), to repay borrowings and for working capital.

Pulse Markets streamlined

Investor Centre's (IC) wholly owned subsidiary, Pulse Markets Pty Ltd has streamlined the new wholesale Corporate Authorised Representative (CAR) business model to be highly competitive.

As such, Pulse Markets has been able to add two new CARs, increasing monthly revenue for the next quarter substantially.

With the effective integration of management and systems, the Pulse Markets' management team has continued to reduced costs, rationalised compliance and debt with an increase in revenue from existing CARS.

Existing CARs are improving performance and market penetration. This has been particularly effective with Mortgage Backed Investments Pty Ltd and Morgan Clarke (Aust) Pty Ltd, which has seen a substantial increase in business performance since the September quarter with a flow-on effect for Pulse Markets' profitability expected in the March 2024 quarter.

Pulse Markets is still in discussion with a wholesale fund manager to provide services commencing in the first quarter of 2024, with more than \$50 million in funds under management.

Pulse Markets' improved administrative processes include the ability to manage databases and more effectively communicate with CARs.

New Responsible Managers appointed

Pulse Markets has confirmed the appointment of its two Responsible Managers who are undertaking an active role in the supervision of Pulse Markets.

- Parminder (Brian) Singh, who brings a strong connection to the new ASX brokerage, Tiger Trading. This is expected to see further opportunities for the organisation in the next six months.
- Graham Holmes from Financial Services Group Australia (FSGA), who brings its association with

Australian Super Finder and more than \$250M of funds under management.





New acquisitions

IC is continuing its due diligence for the acquisition of an operational US stock brokerage. The option to purchase of a 51% interest has not occurred to date however it is expected the transaction will occur in the upcoming calendar year. As mentioned previously this will create a key portal into the US financial markets in the long term.

This company is profitable and if final negotiations are successful, will broaden IC's presence in the diversified financial services sector and add to an increasingly profitable bottom line.



Other activities

Other activities for the quarter included the following:

- IC continues developing its new corporate strategy, involving a broadening of its wholesale and planned development of retail financial product offerings
- IC has maintained its line of credit funding with Amram Pty Ltd for up to \$2 million
- The Notice of Meeting which sought shareholder approval for the change of name of the Company, was finalised and the meeting was held on 17 November 2023 with Shareholder approval being provided.
- A total of 13,709,333 fully paid ordinary shares have been issued to various third party suppliers in lieu of cash during the September quarter, utilizing the Company's 15% capacity. Shareholder ratification of this share issue was obtained at the Company's AGM held on 17 November thereby partially refreshing the Company's ability to issue shares without shareholder approval A further 2,902,877 fully paid ordinary shares were issued in October 2023 to various third party suppliers in lieu of cash.
- Revenue was still down slightly in the quarter due to transitioning the business away from the equity capital market transactions previously conducted by IC's wholly owned subsidiary, Pulse Markets Pty Ltd..

Facility 1:

The Company has an existing credit facility with shareholder Wagering Technology Pty Limited for \$550,000. The facility was fully drawn as at 31 March 2023 but \$180,000 was repaid in the six months to September 2023. The balance of the facility as at the end of the September quarter was \$316,076.

The terms of the loan are:

- Interest: 10% p.a.
- Interest payable every 6 months in arrears
- Term of the loan: 12 months if the loan is not repaid in full in cash by the Termination Date, the borrower may extend repayment of the Loan and payment of all interest by a further 12 months
- Security: Unsecured.

Facility 2:

AMRAM Corp Pty Ltd has provided a \$2,000,000 Line of Credit Facility of which \$1,516,405 has been drawn down at the end of the quarter.

AMRAM Corp Pty Ltd and BIR Financial Limited have common Director, Mr Jody Elliss.

The terms of the facility will be:

- Interest: 12% p.a.
- Interest calculated monthly and payable at the maturity of the Agreement
- Term of the loan: 12 months if the loan is not repaid in full in cash by the Termination Date, the borrower may extend repayment of the Loan and payment of all interest by a further 12 months
- Security: unsecured.

Pulse has continued to improve its performance with additional Corporate Authorised Representatives joining the company. The Directors expect a further improvement in the net operating cashflow in the coming quarters.

8.6.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Investor Centre Limited issued a replacement prospectus on 20 December 2023. The Prospectus is offering 280,000 "A" class redeemable Preference shares with a face value of \$25 per share. The offer closes 1 March 2024. The Directors are confident the offer will meet the minimum subscription and raise between \$3,500,000 and \$7,000,000 in additional capital.

On the basis of the above available funding and the additional funds to be raised through the issue of the Preference shares, the Directors are confident the company will be able to continue as a going concern.
