### **HIGHLIGHTS**

For the first twelve month period of 2023 (FY23), ANTAM's unaudited nickel ore production amounted 13.45 million wet metric ton (wmt), which was used as ore feed for ANTAM's ferronickel plant as well as being sold to domestic market. ANTAM's unaudited nickel ore sales in FY23 reached at 11.71 million wmt.

ANTAM's booked unaudited ferronickel production volume in FY23 at 21,473 ton nickel within ferronickel (TNi), with unaudited ferronickel sales volume amounted to 20,138 TNi.

ANTAM record unaudited gold production figure in FY23 reached of 1,208 kg (38,838 t.oz), with unaudited sales volume amounted to 26,129 kg (840,067 t.oz). In 2023, ANTAM focus to develop the domestic gold customer based.


