COMPLETION OF EXPLORATION DRILLING FOR RARE EARTH ELEMENTS AT PARRAKIE EL 6795, LIMESTONE COAST, SOUTH AUSTRALIA




Figure 1: Granted Licences (black boundary) and Licence Under Application (red boundary) of Ausmon Resources in South Australia for Rare Earth Elements Exploration

Last Friday, the aircore drilling program for Rare Earth Elements ("REEs") along roadside verges at Parrakie EL 6795 (Figure 1) has been successfully completed with 45 holes for a total of 800 metres (average of 17.8m drillhole) (Figure 2). All holes intersected the target Loxton/Parilla Sands (Figure 3) with no incidents or Lost Time Injuries (LTIs).

Every metre of the drilling program will be scanned with the Company's Vanta M series pXRF and selected samples will be sent to ALS laboratory in Adelaide for assay of the full REE suite of elements.

An announcement on the results will be made in due course when received from the laboratory.
