### **Eiffage and APRR consortium appointed for exclusive negotiations for the A412 motorway in France**

Atlas Arteria (**ASX:ALX**) notes that the consortium formed by Eiffage and APRR has been appointed for exclusive negotiations for the A412 Thonon-Machilly motorway.

The project involves the design, construction, financing, and operation of a 16km dual carriageway connecting Machilly to Thonon-les-Bains in Haute-Savoie, known as A412. The concession incorporates free-flow tolling technology and is for a duration of 55 years, commencing from the signing of the concession agreement which is expected later this year.

The project is part of the region's decongestion program. The project will serve and develop the area south of Thonon-les-Bains, extending from the Annemasse-Geneva urban area to the A40 highway. It aims to improve connectivity between the region's various hubs, reduce travel times and enhance safety.

The consortium is committed to creating resilient and sustainable infrastructure that adds value to the region and its residents. The project incorporates a pricing policy that benefits local users, especially commuters. An integral component involves the integration of the new road into the existing landscape, with a focus on enhancing and supporting the region's agricultural production as part of a proactive biodiversity preservation program and ecosystem services restoration.

The infrastructure has been designed to anticipate and address new climatic constraints and incorporates innovative, low-carbon construction methods. It also supports the development of alternative transportation modes, such as the creation of a bike lane along the route and carpooling carparks equipped with electric vehicle charging points.

In Germany, we own 100% of the Warnow Tunnel in the north-east city of Rostock.
