As announced to the ASX on 6 December 2013, the Company entered into a definitive arrangement agreement on 5 December 2013 to effect a merger of the Company and Canadian iron ore developer Champion Iron Mines Limited (CIML) by way of a court approved plan of arrangement under the laws of the Province of Ontario, Canada (Arrangement). Under the terms of the Arrangement, TSX Trust Company (formerly Equity Financial Trust) (Depositary) held and distributed shares to the former shareholders of CIML.
