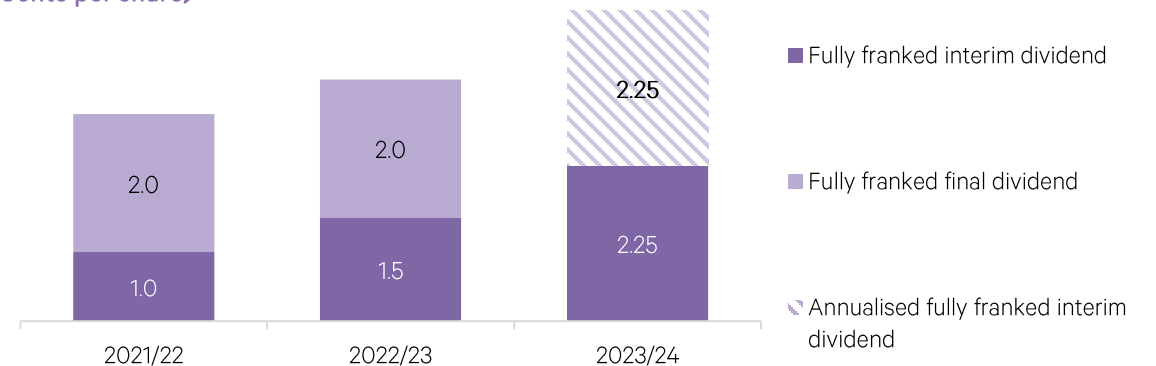

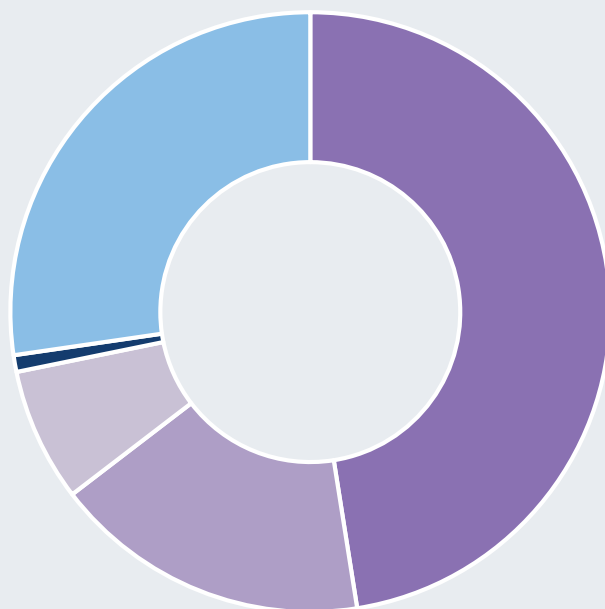

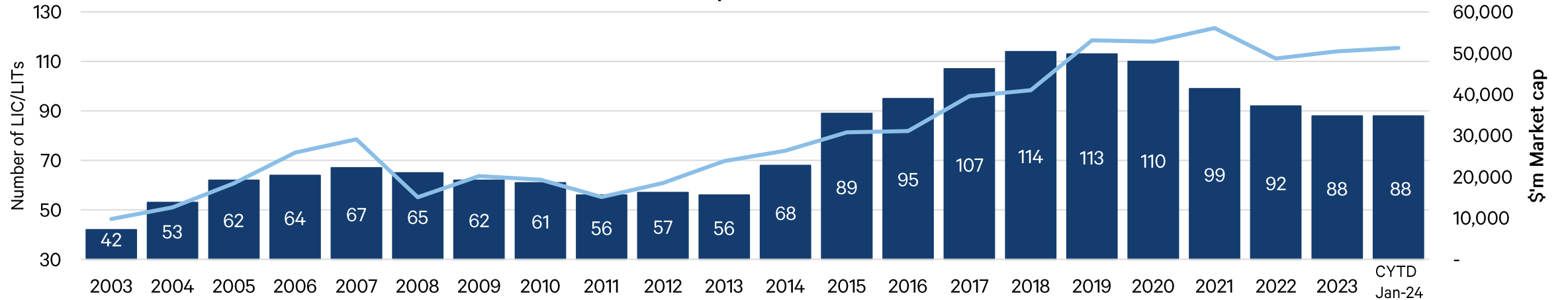

as at 31 December 2023**



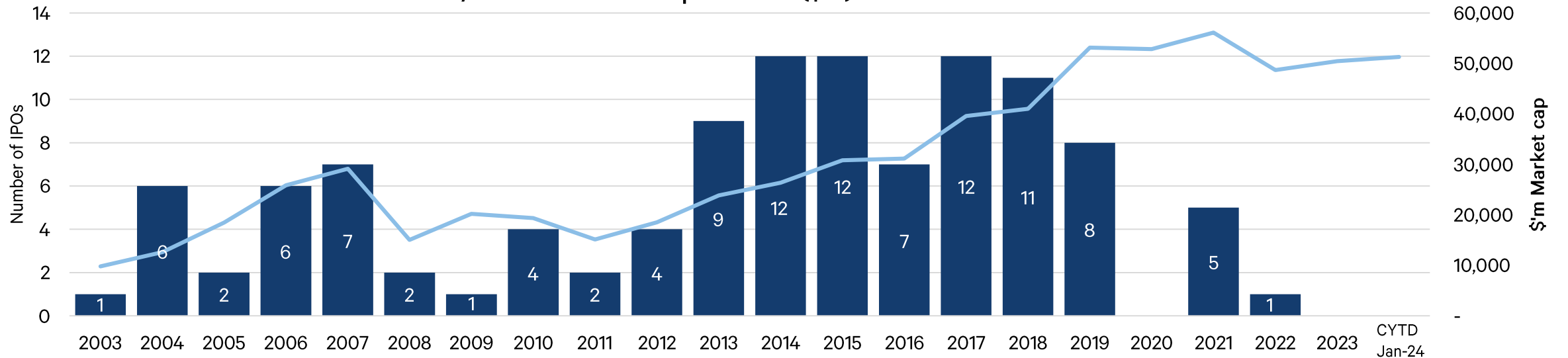
